MEMBERS' TERMS AND CONDITIONS

These terms and conditions must be adhered to at all times by members of Medina Mariners Association

PAYMENT

- All spaces are chargeable for a full year from 1st January to 31st December regardless of which month you join MMA and full payment must be made as per the terms of invoice.
- No discounts will be given if you join MMA later in the year.
- Renewals will be sent to existing members in December of each year and must be paid for by no later than 31st January in the following year.
- Any member who has not paid their renewal invoice in full by 31st January, will be sent a 30-day notice of removal of their dinghy/kayak. If payment is then not received within 30 days, their dinghy/kayak will be removed from the dinghy park and either sold or destroyed.

PARKING

- Car park passes are only provided to members who have a dinghy park space. A spouse will be provided with a car park space if they are also a member.
- Car park passes are for identification only and are not a permit to park. When visiting the dinghy park, always park in the southernmost section of the car park

unless that area is full. All overnight stays MUST be agreed beforehand with the Manager of The Folly Inn.

DINGHY PARK

- All dinghies and kayaks must clearly display a current year dinghy park sticker. The sticker must be visible at all times, even if covers are used, in order for identification to be possible.
- Only one dinghy may be placed in each dinghy space.
- Two kayaks belonging to one family may be placed in a single space (K Row Only), but each kayak must be paid for separately. ***Please inform the Membership Secretary if you want to keep two kayaks in a single space.***
- All dinghies and kayaks must be kept in a seaworthy condition.
- Members must keep their space(s) tidy and clear of weeds at all times.
- No dinghy should not encroach upon an adjoining space. Please ensure that your security chain is long enough to ensure that your dinghy can remain within your marked bay.
- All paths must be kept clear.
- Members are responsible for the security of their dinghies and kayaks, and it is recommended that a chain and padlock (or similar secure device) is used to secure your dinghy/kayak in its space. Thefts are rare but they do happen occasionally, and Medina Mariners Association accepts no responsibility or liability for any theft or damage to dinghies or kayaks stored in its dinghy park.
- Members must use their dinghy space regularly and not leave it vacant for long periods of time, unless special arrangements have been made with the Membership Secretary.
- Any dinghy/rack space not paid for by the 31st January in any year, will be reallocated and any dinghy in the space must be removed from the premises by the owner at the owner's expense without delay.
- Any transfer of ownership/vacation of spaces/swapping of spaces, must be agreed in advance with the Membership Secretary.
- Dinghy/kayak spaces are not transferable upon sale of any dinghy/kayak.
- Road trailers may not be kept in the dinghy park.
- Dinghies should be launched and stored on trolleys or their own wheels.

OAR HOUSE

- No flammable liquids are permitted to be stored in the Oar House or Oar House compound.
- All items stored in the Oar House must be placed in a receptacle (provided by the member) clearly identifying the owner / allocated space.

- Outboard motors may only be stored in units provided by MMA. No petrol containers may be stored in the units or any other area within the oar house or its fenced perimeter. Please use the Outboard Motor Storage Application Form to apply for an outboard motor storage unit.

Notice to all persons using Medina Mariners Association facilities

Any person entering or using any of MMA's facilities does so entirely at their own risk. MMA will not accept responsibility for any loss, damage, personal injury or death howsoever caused to persons entering or using the facilities provided by the MMA. Furthermore, MMA will accept no responsibility for any theft, loss, or damage howsoever arising to property stored in MMA facilities.

Please make sure your boat trolley is securely locked. This is essential. Members are required to ensure that all persons that accompany them or enter the MMA facilities on their behalf are made aware of and have signified their acceptance of this notice. By signing the membership application form with terms and conditions, the applicant is signifying acceptance of this waiver.

In the case of an abandoned, unauthorised or unseaworthy dinghy and/or trailer and/or other property (as defined below), the Committee may:- (a) move the dinghy and/or trailer and/or other property to any part of MMA premises without being liable for any loss or damage to the dinghy and/or trailer and/or other property howsoever caused; (b) upon giving 1 months' notice require the member or former member to collect the dinghy and/or trailer and/or other property; (c) upon giving three months' notice in writing by registered post to the member or former member at his/her last known address shown in the register of members sell the dinghy and/or trailer and/or other property and deduct any monies due to MMA (whether arrears of subscription or facility fees or dinghy park fees or otherwise); (d) if the dinghy and/or trailer and/or other property is unsaleable (in the reasonable opinion of the Committee), after giving notice in writing as aforesaid, dispose of the dinghy and/or trailer in any manner the Committee may think fit and deem the cost of doing and any arrears as aforesaid to be a debt owing to MMA by the member or former member. (e) MMA reserves the right to charge storage for the dinghy and/or trailer and/or other property until such time as the owner collects the dinghy and/or trailer and/or other property or until notice has been served under clause (b) and (c) above. PROVIDED THAT in each case that proper evidence is available to show that all reasonable steps have been taken by the Committee to trace a member or former member and that when and if the dinghy and/or trailer and/or other property is sold the proceeds

of sale (where these exceed the amount of any indebtedness by the member or former member to MMA) shall be placed in a bank deposit account and retained against the eventuality of a claim by the owner (whether he or she be the said member or former member) for a period of six years.

The Committee shall be entitled to treat any of the following as an abandoned, unauthorised or unseaworthy boat and/or trailer and/or other property: (a) a boat and/or trailer and/or other property located in the dinghy park and not displaying a current dinghy park sticker; (b) a boat and/or trailer and/or other property located otherwise than in its properly allocated space; (c) a boat and/or trailer and/or other property that remains in the dinghy park for more than one month after any date advised by the Committee by which boats and/or trailers and/or other property must be removed to allow for maintenance works of the dinghy park or the end of the season date (where applicable); (d) a boat and/or trailer and/or other property which is the property of a member or former member which remains on club premises after any fees payable to the club by any member or former member (whether by way of arrears of subscription or facilities fees, dinghy park fees or otherwise) are more than one month in arrears; (e) a boat and/or trailer and/or other property which is the property of a member or former member which overstays by more than a month following the termination of the storage agreement; (f) a boat and/or trailer and/or other property which is the property of a former member which overstays by more than a month following the termination of their membership. (g) a boat deemed by the Committee as unable to be used on the sea due to it being in disrepair.

In addition to the powers set out above to move, sell or dispose of boats and/or trailers and/or other property the club shall have a lien over members' or former members' boats and/or trailers and/or other property stored in any of MMA's premises in respect of all monies due to MMA, whether in respect of arrears of facilities fees or subscriptions or otherwise and shall be entitled to retain possession of the boat and/or trailer and/or other property until such time as all monies due to the club have been paid in full.
